- Ongoing calls related to collaborations between Psych Associations (refer to email summary)
- Lunch and Learn tomorrow with Suzanne Grimmasey presenting the results of SBC's survey on the mental health impact on our community members 7 registristants
 - Dr. Brooke Sears inquired if she can record and send out to members who cannot attend.
- Collaboration with Ventura Cty PA for 3 CE Law & Ethics training planned for Friday, June 10. Because the application was already approved by CPA it is too late to co-sponsor, but agreement for SBCPA to receive reduced rate (\$89, same as Ventura County PA members) in exchange for sharing day-of and after-event responsibilities and promoting event to SBCPA membership. Ventura County CE chair, Dr Myra Saltoun, is eager to formally co-sponsor future events, will continue to discuss.
- Salon CE for July/August with Dr. Susana Lopez (see related LA Times article: <u>https://www.latimes.com/politics/story/2022-03-20/ethnic-studies-class-spurs-a-racial-reckoning-in-california-wine-country</u>) on topic tentatively related to the impact of race and racism in the therapy room. She is interested, we are coordinating specifics. May prefer 2 hours instead of 90 minutes which sounds fine.
- Hoping to hear back from the Healing Center at UCSB re request for Salon talk. Will follow up.
- Waiting for CPA materials from Dr Bosch & Dr Escobar Walsh for Integration of MH Apps into Telehealth Salon talk, scheduled for 6/17, 12-1:30. This will be a Zoom talk.
- Collaborating with The Retreat at Pacifica and SBCPA was offered free attendance for the upcoming talk with Jungian analyst, Dr. Samuel L. Kimbles. May 8th, 9-10:30am. He will be drawing from his newly released book: *Intergenerational Complexes in Analytical Psychology*, this series will focus on how human suffering relates to unacknowledged traumatic cultural histories that continue to haunt us in the present. This session will explore the many ways that our internal lives are organized and patterned by racial, ethnic, and national identities, as well as personal experiences. Samuel will lead



attendees through to an understanding of how the emotional dynamics generated by these phantom narratives can act as holding containers that allow us to work with these issues psychologically and offer opportunities for individual and collective healing. (no CE's available)
