- 3/14/23 was the 11th Atmospheric River of the season (12th is forecast for tomorrow)
  - Locally Emergency Operation Center (EOC) had been activated for most recent rain event, and evacuations were called, but ended earlier than anticipated; State-wide, many counties impacted and declared "disaster areas" - CPA DRN emails
  - Ready SBC website (https://www.readysbc.org/) has resources available (grant assistance available for homes affected by flooding)
- Locally, ARPA Funding disbursement update, peer to peer, paraprofessional connections and support - SBRN (SB Response Network) provided free PFA (Psychological First Aid) training in North County in both Spanish and English
