#### Agenda Item 16: DEI Committee's Report

- Dr. Pati Montojo provided an update that she has attended DEI Committee Chairs Meeting; moving forward will continue to meet to collaborate.
  - Insights gained: SBCPA has a long way to go to be at a place where DEI is interwoven in all decisions made in the organization. Other psych associations including SF, Redwood City, Alameda, Monterey, have had DEI committees and DEI Committee Chairs for several years prior to the pandemic.
- Monterey County Psychological Association (MCPA) Student Equity Awards: Members contributed funds and MCPA matched those funds. It is a financial award given to two doc students at Cal State Monterey and UCSC. As part of this award, each student will be offered several mentoring sessions with psychologists from MBPA to support and guide them in preparing for graduate school and their career development. We may want to consider this for our organization, to enhance mentoring opportunities, increase student membership, and support doctoral students from historically underrepresented and marginalized groups.

- Dr. Cristina Donaldson discussed the possibility of including this as a part of Legacy Awards.
- Provided update on the call that went out for BIPOC Psychologists of Color Support Group. Interest from two psychologists. Announcement went out and we will be meeting soon, once a month, every other month.
